
SP1 Package outline (dimensions in mm)










Typical IGBT Performance Curve






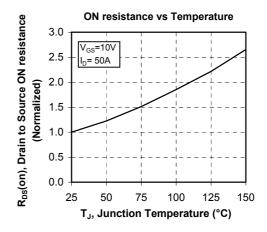
















































Typical chopper diode Performance Curve


